

ORDINANCE 3
TO LICENSE SHOWS AN PEDDLING IN AND FOR
THE INCORPORATED VILLAGE OF OTTOVILLE
PUTNAM COUNTY OHIO

BE IT ORDAINED BY THE TOWN COUNCIL OF THE INCORPORATED VILLAGE
OF OTTOVILLE, PUTNAM COUNTY, OHIO

SECTION 1: THAT BEFORE ANY PERSON OR PERSONS SHALL EXHIBIT ANY EXHIBITION OR SOW OF ANY KIND FOR ANY FEE OR REWARD WITHIN THE CORPORATE LIMITS OF SAID VILLAGE SUCH PERSON OR PERSONS SHALL APPLY TO THE MAYOR OF SAID VILLAGE FOR A LICENSE FOR THAT PURPOSE AND UPON PAYMENT BY SUCH PERSON OR PERSONS SAID MAYOR, THE SUM OF NOT MARE THAN TEN DOLLARS, NOR LESS THAN FIFTY CENTS, SAID MAYOR IS HERE BY AUTHORIZED TO ISSUE SUCH LICENSE, SUCH I LICENSE BE OF NO EFFECT FOR MAYOR THAN THREE DAYS, AFTER DATE SUCH LICENSE TO STATE THE TIME OF SUCH EXHIBITION OR A SHAOW AND THE AMOUNT SO PAID THERE FOR: THE MAYOR SHALL BE ALLOWED OUT OF SUCH FUND THE SUM OF TWENTY FIVE CENTS FOR HIS SERVICES AND THE REMAINDER TO BE PAID BY HIM INTO THE TREASURY OF SAID VILLAGE, AND THAT IF ANY PERSON OR PERSONS SHALL EXHIBIT OR SHOW IN ANY, ANY SUCH EXHIBITION OR SHOW WITHIN SAID VILLAGE CORPORATE LIMITS WITHOUT HAVING FIRST OBTAINED SUCH LICENSE AS PROVIDED IN THE SECTION, HE, SHE OR THEY SO OFFENDING SHALL BE DEEMED GUILTY OF A MISDEMEANOR AND UPON CONVICTION THEREOF FOR EACH AND EVERY SUCH OFFENSE SHALL BE FINED IN ANY SUM NOT EXCEEDING TWENTY DOLLARS NOR LESS THAN FIVE DOLLARS, AND COSTS OF PROSECUTION AND BE ORDERED TO STAND COMMITTED UNTIL SUCH FINE AND COSTS ARE PAID.

SECTION 2: THAT IT SHALL UNLAWFUL FOR ANY PERSON OR PERSONS TO PEDDLE SUCH OR OFFER FOR SALE OR RETAIL (AS SUCH PEDDLERS) ANY GOODS , WARES, MERCHANDISE OR MEDICINE WHATEVER, WITHIN THE CORPORATE LIMITS OF SAID VILLAGE WITHOUT FIRST OBTAINING A LICENSE OR PERMIT THERE FOR FROM THE MAYOR OF SAID VILLAGE, FOR WHICH SAID LICENSE OR PERMIT HE, SHE OR THEY SHALL FIRST PAY TO AID MAYOR A SUM NOT LESS THAN FIFTY CENTS NOR MORE THAN TEN DOLLARS PER DAY AT THE DESCRETION OF THE MAYOR , AND ANY SUCH PERSON OR PERSONS FAILING TO COMPLY WITH OR VIOLATING THE PROVISIONS OF THIS SECTION OF THIS ORDINANCE HE, SHE OR THEY SHALL BE DEEMED GUILTY OF A MISDEMEANOR, AND ON CONVICTION THERE OF SHALL BE FINED IN ANY SUM NOT EXCEEDING TWENTY DOLLARS , NOR LESS THAN FIVE DOLLARS AND COSTS OF PROSECUTION AND MAY BE ORDERED TO STAND COMMITTED UNTIL SUCH FINE AND COSTS ARE PAID AND THE MAYOR SHALL RECEIVE THE SUM OF TWENTY FIVE CENTS OUT OF SAID LICENSE FUND FOR ISSUING SUCH LICENSE AND PAY THE REMAINDER INTO THE TREASURY OF SAID VILLAGE.

SECTION 3: THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FULL FORCE FROM AND AFTER THE ELEVENTH DAY OF OCTOBER A.D. 1890
