

RESOLUTION # 2013-01

ANNUAL APPROPRIATION RESOLUTION

The Council of the Village of Ottoville, Putnam County Ohio met in Special session on the 7th day of January, 2013, at the Ottoville Municipal Center with the following members present: Mr.'s Timothy Rieger, Carl Byrne, Randolph Altenburger, Anthony Langhals, Jerold Markward, & Mrs. Karen Hoersten.

Mr. Carl Byrne moved the adoption of the following Resolution:

A Resolution to make appropriations for Current Expenses and other Expenditures of the Village of Ottoville, State of Ohio, during the fiscal year ending December 31, 2013.

BE IT RESOLVED by the Council of the Village of Ottoville, Putnam County, State of Ohio, that, to provide for the current expenses and other expenditures of the said Village of Ottoville during the fiscal year ending December 31, 2013, the following sums be and the same are hereby set aside and appropriated for the several purposes for which expenditures are to be made for and during said fiscal year, as follows, viz:

Total Annual Appropriations \$ 1,690,067.15

Mr. Anthony Langhals seconded the Resolution and the roll being called upon its adoption the vote resulted as all approved.

And the Village Fiscal Officer is hereby authorized to draw warrants for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the Council authorized by law to approve the same, or an ordinance or resolution for Council to make the expenditures: provide that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance. Provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of Council for items of expense constituting a legal obligation against the Village, and for purposes other than those covered by other specific appropriations herein made.

This resolution shall take effect at the earliest period allowed by law.

Section 5705.39, R.C. – No appropriation measure shall become effective until the County Auditor files with the appropriating authority...a certificate that the total appropriation from each fund, taken together with all other outstanding appropriations, do not exceed such official estimate of a mended official estimate. When the appropriation does not exceed such official estimate, the county auditor shall give such certificate forthwith upon receiving form the appropriating authority a certified copy of the appropriation measure...
